

CRO PLAYER AGREEMENT

I, the undersigned, wish to participate in events run by Creative Roleplaying Organization (hereinafter referred to as "CRO"). I recognize and understand that playing CRO involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from the use of boffer weapons and injuries resulting from tripping or falling over terrain in the CRO playing area. In addition, I recognize that the exertion of playing CRO could result in injury or even death. Despite these and other risks, and fully understanding such risks, I wish to play CRO and hereby assume the risks of playing CRO.

I also hereby hold harmless the Operators of CRO (hereinafter referred to as the "Operators") and indemnify them against any and all claims, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing CRO. I hereby release the Operators from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns, I hereby certify to the Operators that I am in good health and do not suffer from any ailment which could be exacerbated by the exertion involved in playing CRO.

I hereby promise to play CRO only in accordance with the rules of CRO as set forth by the Operators. In particular, I agree to stay within the boundaries of the playing area and not to chase or run after anyone over dangerous terrain. I agree to ask the Operators for clarification of any rule or safety procedure for further instruction as regards anything I don't understand about the equipment and supplies, or as regards anything else that may affect the safety of, or playing of, CRO.

I understand that participation in CRO is entirely voluntary and I am never required to undergo any task I feel is disagreeable or unpleasant. I understand that CRO utilizes the entire campsite, and that there will be activities that may involve walking a considerable distance. I understand that CRO does not provide flashlights, and that it is expected that I will bring a personal light source to utilize for safety purposes.

I also understand that if I submit pictures to CRO taken during a CRO event or containing CRO subject matter, I consent to the submitted pictures being used by CRO on its website, in its rule book, or in any other promotional venue of CRO.

I agree not to use alcohol or illegal drugs at CRO nor will I bring alcohol or illegal drugs onto the CRO campsite. If suspected of being under the influence of illegal drugs or alcohol during events run by CRO I understand that I will be asked to leave the site immediately and without refund.

I have read this waiver of liability and assumption of risk carefully, and understand that by signing below I am agreeing, on behalf of myself, my estate, my heirs, representatives and assigns not to sue the Operators or to hold their insurers liable for any injury, including death, resulting from my playing CRO. I intend to be fully bound by this agreement.

I understand that this agreement is valid for the calendar year in which it was signed. I further agree that I have read the entirety of the safety regulations set forth in the CRO Rulebook and agree to follow them. I understand that failure to follow any of these rules may result in being asked to leave CRO permanently and without refund.

BY VIRTUE OF MY SIGNATURE I AGREE TO ALL TERMS AND CONDITIONS SET FORTH ON THIS DOCUMENT.
